High School Juniors, Novice and Open National Style
French Senior (North & South) National Style

- This is a values debate; no plan is necessary but models may be used.
- Due to the early date of the **National Seminar**, alternative selection criteria was used.
- This is the qualifying tournament for the **Western Canada Debate Championships** in Saskatoon. The top High School Novice speaker from Regina and the South Rural region will join the top individual speakers from Saskatoon and the North Rural region as Saskatchewan's delegates to Westerns.
- All debaters are required to participate in an impromptu speech round following the final round of debate. This is a practice, but scored round. Top Debaters in each of the Junior & Senior categories will have their registration fees waived to the SEDA Provincial Speech Tournament. Delegates to the National Speech Competition will be selected at the Speech Tournament in January.

Limit: 50 teams (approximately 10 per division, with a limit per club to ensure all clubs may enter)

Costs: \$30 per team. Make cheques payable to USDS.
SEDA will be collecting all registration forms. Please bring fees owing to the tournament registration.

Discount! Teams are strongly encouraged to bring one judge per registered team - any team bringing a pre-registered judge will receive a \$5.00 discount on their registration fee. Please contact SEDA by the deadline with your confirmed judges' names and email addresses (or other contact info).

Deadline: Registration deadline is Monday, October 26, 2009.
Registrations will be confirmed by email on Wednesday, October 28. Please advise SEDA ASAP if there are any cancellations. Any teams cancelling on the day of the debate are expected to pay the tournament registration fee.
